**TERMINATION OF CONTRACT** - It is agreed between the parties that this contract may be terminated by giving Thirty (30) days written notice by either party may terminate this contract. Before termination by the member, all charges and dues owed must be paid. In the event that the member or his/her family or guest violates the by laws, rules or regulations of the Club, the Club at its option, may terminate said membership.

**GRACE PERIOD FOR CHARGES** - New members may not charge any merchandise for a period of ninety (90) days beginning on the date of contract. Cart fees and range fees are excluded.

**LATE CHARGES** - All indebtedness to the club shall be due and payable when statement is rendered. Dues shall be payable in advance. A service charge of \$25.00 per month shall be added to all unpaid balances over 60 days past due. Any member that is over sixty (60) days late may no longer charge to his/her account.
